The Coast Guard Auxiliary Celebrates 80th Year of Service

Congress established the USCG Auxiliary under title 14, §§ 23 of the U.S. Code on June 23, 1939, as the United States Coast Guard Reserve. Two years later, the organization was re-designated as the United States Coast Guard Auxiliary, to support all Coast Guard missions except roles that require "direct" law enforcement or military engagement.

Few agencies were more profoundly changed by the terrorist attacks of Sep 11, 2001 than the Coast Guard. Faced with a renewed mission to protect the homeland, the service was one of the key agencies to be folded into the Homeland Security Department. The Coast Guard was tasked with increasing security along America's 95,471 miles of coastline, and in 360 ports and harbors, but with no increase in personnel.

The Auxiliary contributes over 4.5 million hours of service each year and completed nearly 500,000 missions in service to support the Coast Guard. Every year volunteer Auxiliarists help to save approximately 500 lives, assist 15,000 distressed boaters, conduct over 150,000 safety examinations of recreational vessels, and provide boater safety instruction to over 500,000 students. In total,

the Coast Guard Auxiliary saves taxpayers hundreds of millions of dollars each year on Missions carried out in this community by Flotilla 14-7.

The local flotilla provided 2,307 hours of support for Recreational Boating Safety Activity by the Flotilla through May 31, 2019 included:

- Marine Patrols involving 142 hours of service.
- Provided Vessel Safety Checks to 145 recreational boats!
- Found 125 kids ages 6 and up wearing their life jackets, either at the dock or on boats in local waterways.
- Provided 31 hours of Public Education Programs in 11 Safety Courses so far in 2019.
- Outreach and Education Program additional class to our partners at the- Navy Sea Cadets.

Wildflower Meadow Group

During our July meeting we worked on improving edges for the meadow. The heat, humidity, and bugs discouraged us from working harder but there's always something to do. Cleaning the edges clarifies boundaries and it's almost like framing a picture. In July we focused on edges of the path and next time we may clean edges on the outside. One of the things I like about our meetings is we don't always know ahead of time the work we'll do. It depends on conditions of the meadow, our backs, and the season. The thing is there's always something to do and learn. Always. And we're outside.



One of the most prolific flowers in the meadow early in July is the *gaura*, also known as *wandflower*, whirling butterfly, or bee blossom. The long branched stems grow from 15 inches to 4 feet and the small, airy flowers bloom longer than many other flowers. *Gaura* blossoms are most prolific early in summer and attract bees and butterflies. It's also host to caterpillars of white sphinx moths. *Gaura* like full sun, tolerate drought, and has few pest problems.

Florida Sales Tax on Commercial Leases Reduced in January 2020

Good news for Commercial Landlords, the reduction on state level sales taxes continues to decline. Florida is reducing the state-level sales tax rate on commercial leases for occupancy periods beginning on or after January 1, 2020 down to 5.5%. However, counties are still imposing the local option surtax so be careful to check your county's guidelines. The local option surtax varies between 0.5% to 1% for those counties that impose it. Currently, for 2019 St. Johns County has an additional 0.5% surtax.

Commercial property owners and management companies should be aware of this reduction for lease payments related to periods starting on or after 2020. It is recommended to adjust invoices for rental periods commencing on or after January 1, 2020 to account for the 0.2% reduction in the state tax rate.

Additionally, tax is not only levied on the base rent alone but also on any consideration required to be paid by the tenant as a condition of occupancy. Payments for services and use of the property, such as charges for common areas, janitorial services, insurance, and other types of payments are considered rent and subject to tax, regardless of whether those payments are paid to the landlord directly or indirectly. For example, a commercial lease with a base rent of \$1000 per month, and the tenant pays the insurance and mortgage directly to the bank of \$600 per month, means that sales tax is charged on the total of \$1600 and not just the \$1000.

It is the responsibility of landlord to register with the department and collect and remit the proper amount of tax. Any agent who receives payments on behalf of a property owner must also register with the Department of Revenue.






The Coast Guard Auxiliary Celebrates 80th Year of Service

- Visited Marine Dealers 196 times to date in 2019.
- Help maintain radio mobile Relay Facilities to augment Rescue 21 services during weather and other emergency events.

Each day, the 37,000 men and women of the active duty United States Coast Guard, including 5,000 Reservists and 25,000 Auxiliarists provide services to over 3.4 million square miles of Exclusive Economic Zones, 95,471 miles of coastline, and in 360 ports and harbors.

During the Hurricane Season in 2017, covering active storms Harvey, Irma and Maria the Coast Guard deployed 29 cutters, 50 aircraft and 75 small boats which conducted over 8,000 rescues that saved more than 11,300 lives. Many of these missions for Safety and Search and Rescue were augmented by the Auxiliary. This time period was one of the largest rescue operations in Coast Guard history.



What else happens during an average Coast Guard day?

- Small boats are underway for 596 sorties/missions.
- Aircraft fly 164 missions, logging 324 hours
- Cutter and small boat crews rescue 15 illegal immigrants.
- Marine Safety personnel open 8 new cases for marine violation of federal statutes.
- Marine Inspectors board 1,100 large vessels for port safety checks.
- Vessel examiners conduct 25 commercial fishing vessel safety exams and issue 11 fishing vessel compliance decals.
- Pollution investigators respond to 20 oil or hazardous chemical spills totaling 2,800 gallons.
- Buoy tenders and Aids to Navigational Teams service 235 aids to navigation.
- Vessel Traffic Service controllers assist 2,509 commercial ships entering & leaving U.S. ports.
- Auxiliarists nationally conduct 1,077 vessel safety checks and teach boating safety courses to 1,750 boaters.

Never, EVER pay with Gift Cards!

Over the past few years we have seen a large increase in scams where a person on the phone demands payment in the form of Gift Cards. No matter who they say they are with, if they request that payment be made in the form of gift cards, they are a scammer. PERIOD, End of Story.

If you paid a scammer with a gift card, tell the company that issued the card right away. When you contact the company, tell them the gift card was used in a scam. Ask them if they can refund your money. If you act quickly enough, the company might be able to get your money back. Also, tell the store where you bought the gift card as soon as possible.

Jennifer Leach, the Federal Trade Commission's Assistant Director, says:

"So here's the most important thing for you to know: anyone who demands payment by gift card is always, always, always a scammer."

The FTC states that the total "reported" losses to gift card scams was \$20 million in 2015, increasing in 2016 to \$27 million, and in Sept of 2018 it had already exceeded \$53 million. This trend upward is alarming, especially when you consider this represents only the reported losses.

They request that anyone who has been

a victim of these scams should file a report at FTC.gov/giftcards or call 1-877-FTC-HELP. The FTC Complaint Assistant is very easy to use, and thorough in gathering the facts about the scam.

If the cards are the re-loadable kind (most are), they should NEVER be used again. The scammer will have the ability to drain any funds added to it. Do not throw them away or shred them, as you will need information on them to report your loss correctly.

After being scammed in this way, the sad truth is that the scammer will keep calling back making more demands. Many report repeated call backs from scammers, often ten or more calls per day.

Please share this information with your friends, family and neighbors. St Augustine is targeted heavily by this, and all sorts of other scams, and we need to ensure that everyone is informed.

If you work for yourself, you can combine employee and employer contributions, so if you use the 3 percent matching rule, and you earn enough to fully match employee contributions, you can put in up to \$26,000 per year (or \$32,000 if you're 50 or older). Alternatively, you could contribute 2 percent of each eligible employee's compensation each year, up to a maximum of \$5,600, regardless of whether the employee contributes. Contributions to your employees are tax deductible.

- **"Owner-only" 401(k) plan:** If you have no employees other than your spouse, you can establish an "owner-only" 401(k) plan, which functions similarly to a 401(k) plan offered by a large employer. Between salary deferral and profit sharing, you can contribute up to \$56,000, in pre-tax dollars, to your owner-only 401(k), or \$62,000 if you're 50 or older. Like a SEP-IRA and SIMPLE IRA, a 401(k) provides the potential to accumulate tax-deferred earnings. However, you could choose to open a Roth 401(k), which can be funded with after-tax dollars. With a Roth 401(k), your earnings can grow tax-free, provided you've had your account at least five years and you don't start taking withdrawals until you're at least 59-1/2.

Which plan is right for you? The answer depends on several factors, such as whether you have any employees and how much money you can contribute each year. But all the plans mentioned above are generally easy to establish, and the administrative costs are usually minimal. Most important, any one of them can help you build some of the resources you'll need to enjoy the retirement lifestyle you've envisioned. To select an appropriate plan, you may want to consult with your tax and financial advisors. In any case, don't wait too long. Time goes by quickly, and when you reach that day when you're a "former" business owner, you'll want to be prepared.

St. Johns County Sheriff's Corner

Back to School Safety

This month I would like to remind all of our citizens as well as visitors that schools will be back in session this month which means that our children will be going to and from school daily. District wide students return to the classroom very soon. I would ask all of you to take extra time and be extremely careful in school zones as well as at bus stops. In heavily traffic areas, motorists should plan on longer commutes and follow the speed limit in School Zones. Deputies will be at school zones throughout the county to monitor those zones and to address any violations accordingly. Drivers need to be advised that speeding fines are doubled if they occur in a school zone. Deputies will also be in unmarked vehicles seeking any motorists who pass stopped school buses while loading or unloading students. Remember ALL traffic in both directions must come to a complete stop for school buses that are stopped, displaying the "stop" signal. Motorists traveling in the opposite direction are exempt from stopping if the roadway is separated by a median of at least five feet wide. These infractions will be strictly enforced.

Motorists are also reminded to take extra precaution at school bus stops where eager youngsters, many riding the bus for the first time, may dart into the street as the bus arrives. Here are some safety rules to pass along to children that ride a school bus. Arrive at your bus stop at least five minutes early and stand at least ten feet away from the roadway. Be sure to wait until the bus stops, the door opens and the bus driver says it's alright to enter before stepping onto the bus. Be

careful that clothing with drawstrings and book bags with straps or dangling objects do not get caught in the handrail or door when exiting the bus. Walk in front of the bus, never behind the bus. Remember if you can't see the bus driver, he or she cannot see you. After getting off the school bus, stop at the edge of the bus and look both ways before crossing. If you were to drop something beside the bus, make sure to you tell the driver before attempting to pick it up.

Students who walk to school should do so on a sidewalk if it is available. If there is no sidewalk, students should walk against the flow of traffic and be sure to cross at marked crosswalks. Those who ride a bicycle should remember to ride with the flow of traffic and follow all traffic signs and signals. Remember students are required to wear a bicycle helmet. Now that schools will soon open for another year, please take the extra time needed and watch out for our most precious resource, our children.




