#### Structure, Governance & Management

Auchterarder & District Community Trust is a Trust governed by a Trust deed.

Trustees are appointed under the terms of the trust deed.

The trustees meet every three months to consider any applications received and to make awards in accordance with the published guidelines agreed by the trustees.

Applications of £1,000 or under are considered between meetings by way of email correspondence.

The trustees also consider the appropriate location for its funds and seek advice from an Independent Financial Advisor where and when appropriate.

#### Objectives and Activities

The trust exists for the advancement of community development.

#### Financial Review

The trust received one grant in the course of the year. This was £15,907 from Scottish Power Renewables - the twelfth of 25 index-linked annual instalments - from the Community Benefit Fund for Green Knowes Windfarm.

The total awarded (and paid out) from unrestricted reserves was £35,372 as detailed above.
