THE AMENDED AND RESTATED RULES SHALL REMAIN IN FULL FORCE AND EFFECT EXCEPT AS SPECIFICALLY SET FORTH HEREIN BELOW.

Rule 19 in the Amended and Restated Rules is hereby deleted in its entirety, and the following Rule 19 shall be substituted in lieu thereof:

"19. Construction Hours. Construction, including painting of units, must be done between 8:00 a.m. and 5:00 p.m. Monday through Friday, and on Saturdays between 8:00 a.m. and 12:00 p.m. The owner must notify the office prior to scheduling any Saturday work."
