# ARTICLES OF INCORPORATION OF THE BARCLAY OWNERS' ASSOCIATION, INC.

We, the undersigned natural persons of the age of the Wenty Conception Divisio one years or more, at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

#### ARTICLE I

The name of the corporation is THE BARCLAY OWNERS' ASSOCIATION, INC., hereinafter known as the "Corporation".

#### ARTICLE II

The Corporation is a non-profit corporation.

## ARTICLE III

The period of its duration is perpetual.

### ARTICLE IV

The purpose or purposes for which the corporation is organized are:

To administer, enforce, and otherwise implement, in any and all ways, the maintenance and operation of The Barclay Condominium Residences, a condominium project located in Houston, Harris County, Texas, established pursuant to the Texas Condominium Act (Article 1301a of the Texas Revised Civil Statutes), and to exercise and perform all of the functions of a "Council of Co-Owners", as that term is defined in such Act.

To consent, approve, grant permission, and otherwise perform all such functions and do any and all things that may be permitted or required by the restrictions pertaining to said condominium project.

To promote and supervise the beautification, care, maintenance, and upkeep of said condominium project.

In general, to carry out any other activity in connection with the foregoing and to have and exercise all the powers conferred by the laws of Texas upon non-profit corporations formed under the Texas Non-Profit Corporation Act and to do any and all other things hereinbefore, set forth to the same extent as natural persons might or could do.

## ARTICLE V

The street address of the initial registered office of the corporation is 2600 Bellefontaine Street, Houston, Texas 77025, and the name of its initial registered agent at such address is W. G. Kanke.

## ARTICLE VI

The number of directors constituting the initial board of directors of the corporation is three (3) and the names and addresses of the persons who are to serve as the initial directors (or trustees) are:
