Add: 54. Flooring Hardwood, ceramic tile, mosaic, marble and similar floors are prohibited on the second and third floors.

Delete: 52. ...Lost or stolen cards will be replaced at a cost of \$10.00 per card or remote...

Add: 52. ... Lost or stolen cards or remotes will be replaced at the price of the card or remote paid by the Barclay Owners' Association rounded up to the next dollar..

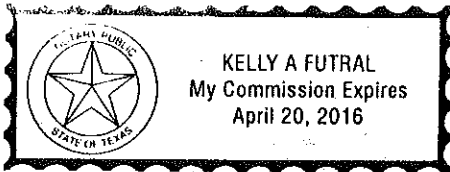
